5. WARRANTY

The Phibrows Artist accepts liability in compliance with the legal measures and regulations in the case of negligence or carelessness or intentionally or negligently caused injuries or threat to life, body, and health. The Artist also is liable for violations of the obligations specified in the Agreement.

6. EXPLANATION

- ❖ The client is informed in detail by the Phibrows Artist about specific risks of eyebrow drawing treatment using the microblading technique.
- ❖ The following risks are specifically explained to the client:
- ❖ During the treatment, despite the staff expertise and all the precautionary

measures, the injury is possible.

- ❖ Despite the application of the most advanced and the top quality pigments, the allergic reaction is possible but rare. The client is informed about this and he/she assumes liability.
- ❖ During and after the treatment temporary swelling, redness and/or itching may occur. Experience tells us that these symptoms are temporary.
- ❖ Depending on the skin structure after the first treatment small scabs with a loss of drawn hairs may occur and colour intensity may change. In the first seven days, eyebrow are up to 40% darker and 10-15% thicker. Colour i.e colour reflection depends on the natural skin pigment.
- ❖ The shape is determined according to the face proportions. Symmetry is determined digitally, with closed eyes because of the negative impact of facial expression.
- ❖ The pigment is absorbed differently due to differences in the skin quality, thus there is no warranty for the treatment success.
- ❖ Depending on the skin structure it should be noted that change in the colour intensity is possible and that one or more additional treatments will be required.
- ❖ The minimum or maximum duration of eyebrow drawing treatment cannot be determined with certainty, nor can the warranty be given to performed treatment.
- ❖ The first correction is done four weeks after the treatment. For oily skin, it is necessary to perform more corrections.
- ❖ Permanent make-up always leads to skin injury. Therefore, it is important to carefully and gently nurture your skin after the treatment to allow healing without complications. Inadequate care in healing phase of the skin can lead to poor results and the Artist cannot be liable for it.
- ❖ In the next seven days, the client is required to pay attention to the following:
- ❖ Half an hour after the end of the treatment, eyebrows should be thoroughly rinsed with lukewarm water and then a thin layer of Vaseline (petroleum Jelly) shall be applied.
- ❖ This procedure shall be repeated every hour, at least 5 times a day to prevent the scab formation.
- ❖ For post-treatment care use only provided cream or pure Vaseline. Please do not use any other creams except the ones provided to you in order to prevent possible infections or allergic reactions.
- ❖ In the first two weeks after the treatment avoid public bathing, sunbathing, tanning salon, sauna, beauty treatments and intense training accompanied by sweating (sports activities), contact with the dust (household chores, etc.)

BEFORE ALL PROCEDURES

This treatment cannot be done whilst pregnant or when breastfeeding

Please do not book on the days you have period

Please do not drink any caffeinated drinks or take aspirin/medicine within 48 hours before treatment

Botox should be performed 3 weeks prior to or 3 weeks after the procedure

Stay away from the sun, no sunbathing or spray tanning for 30 days before the procedure

Microblading cannot be performed on dark tattooed eyebrows unless an old tattoo is removed or faded until very light

If you have large pores or oily/very oily skin, your results will appear softer/solid or powdered looking. Microblading is not recommended for people with oily skin

If you are on multiple medications OR having diseases OR any kind of allergies, please check with your doctor before we can carry out the safe procedure. The client has to fill in the health form and sign the consent when they are booking an appointment.

Please note that the whole microblading session take up to 2 hours

AFTERCARE INSTRUCTIONS

Rinse the brow area with warm water or neutral soap (baby's) by using cotton pads, after that apply a very thin layer of Skin Candy. Repeat this process 3-5 times in first 24 hours to avoid dry scabs

Apply Skin Candy 3-5 times a day for 5 days

Stay away from the Sun in the first 30 days

IN THE FIRST 7 DAYS OR UNTIL THE BROW HEALING UP

NO cream or makeup in the eyebrow area

NO sweat, avoid workout that will involve a lot of sweating like a sauna, facial massage, or steaming. Sweat is salty and will prematurely fade, blur or cause the pigment not to take at all

The area may appear uneven, dry, itchy, tender, red & irritated. This is all 100% normal. DO NOT PICK.

These symptoms will dissipate each day and vary on an individual basis.

IN THE NEXT 30 DAYS

Avoid laser Treatment over the treated area (Fraxel laser, IPL), because they can destroy the pigment and cause burns

Use of antibiotics and hormonal therapy can lead to a faster fading

Always protect the eyebrows from the sun

The brows colour will be 40% less dark and hair strokes will be 10% to 15% shorter after 4 to 6 weeks. That is why we need perfecting procedure to fine tune any area that has faded too much. Healing is specific to each client. It is important to realize that you will need a colour boost every (no prior) 12-18 months to maintain its fresh natural appearance. Fading WILL happen after each procedure. We do not have control over your bodies healing process
